The junior aggregate went to Alyssa Britnell who improved greatly throughout the season, second place went to Josh Hawkes and third place went to Nick Fidler. The short course aggregate winner was Brendan Hawkes. The Brian Gudgeon Best club person trophies went to Heath McLennan for doing a great with setting up and packing up of all the equipment each week throughout the season and also for helping out with the juniors. So congratulation to all the winners.

Throughout the Cross country season Wendouree had a large contingent of athletes go to all the AV events as part of the Ballarat team, which is great especially for our juniors. The under 14 boys team which comprised of Wendouree runners such as Sam Williams, Nick Fidler, Matt Catterson and Josh Hawkes had a great result coming 2nd overall and the 40+ men which Neville Down, Phil McLennan and Steve McLennan were mostly a part of finished 3rd overall. In the Champion Athlete individual awards we had Sam Williams finish first and Nick Fidler 3rd and in the 40+ women Angela Williams finished first and also took out the Open country athlete award, with Michelle finishing equal third.

We also had a number of athletes compete at State and National level throughout the season. At the Nationals in Tasmania Sam Williams finished 7th place in the under 14 boys and Nick Fidler finished in six place 6th in the under 13 and in the under 20 men's Mitch Thompson finish in 11th

We would again like to thank our ex junior athletes for continuing to help out with the Little Aths season, Alyssa Britnell, Grace Nichols and Anna Zehrung just to name a few well done and thank you.

The 2013/2014 Track and Field season saw a lot of new faces and lots of good performances. A home AV Country Championships saw huge numbers of Wendouree athletes competing resulting in an impressive 21 Gold medals, 22 Silver medals, and 15 Bronze medals. Wendouree was a constant presence at local AV Shield meets with strong support by both athletes and officials every week.

The quality performances continued at the Victorian Junior Championships and the Victoria Open Championships. Our junior athletes came home with 5 Gold and 4 Bronze medals while our seniors produced 2 Gold medals. Heading up to Sydney, seven of our junior athletes competed at the Australian Junior Track and Field Championships coming home with two Silver and one Bronze medals.
